State aforesaid for and in consideration of one hundred dollars to  
me in hand paid by Joseph Batson of the same State and dist-  
- ict aforesaid have granted Bargained and sold unto the  
said Batson a certain parcel or Tract of Land containing one  
hundred Aers more or less situate in Greenville District on the  
waters of Puddy River. beginning on a poplar corner on  
the old original line from thence S. 50. E. to a boundary line made  
by Lewis Duncan and Martin banner thence the Conditional  
line crossing the mouth of David Mc Daniels Spring branch  
to Stake corner on Henry Halls line thence S. Halls line to a Stake  
corner on the old original line thence S. old line S 63. to the  
beginning poplar corner Together with all the Rights  
and privileges belonging to the premises and further I do  
Covenant with the said Batson and his heirs and  
forever defend the a above mentioned premises aforesaid  
from himself his heirs and assigns and every other person  
or persons lawfully claiming the same or any part  
thereof to the S<sup>d</sup> Joseph Batson and his heirs for ever In witness  
where of I have hereunto set my hand and seal this nineteenth day of  
February one thousand eight hundred and twelve signed sealed and delivered
