Inn of Greenville district District and State aforesaid for and in consideration  
of three hundred dollars to me in hand paid by William Tucker of State  
and district aforesaid have granted Bargained Sold and released and by  
these presents do grant Bargain Sell and release unto the Said William Tucker  
all and singular the plantation or tract of land whereon Tom Tucker now  
lives containing two hundred acres more or less Situated in the State and  
district aforesaid lying on both sides of the devil's fork a branch of the middle  
fork of Saludia river Beginning at an Ivy corner on the East side of the  
tract running N. 10° W. 9 chains E to a red oak & thence N. 63° W. 6.50 to a dogwood  
thence N. 10° W. 14 chs to a Post oak & by another thence S. 82° W. 57 chs to a red  
oak & thence S. 34° E to a stake on the back line thence to the beginning it  
being part of a tract of land Granted to Jeremiah Hibbert and from him  
conveyed to John Lovell and from to me Together with all and singular  
the rights members hereditaments & appurtenances to the said premises belonging  
or in any wise incident to have and to hold all and singular the  
said premises unto him the Said William Tucker his heirs and assigns  
forever against myself my heirs Executors or administrators or any other  
person or persons whomsoever lawfully claiming or to claim the same  
or any part thereof In Testimony whereof I have hereunto set my hand  
and affixed my seal this twelfth day of October in the year of one  
thousand eight hundred and thirty
