 lying in the State and District aforesaid on a branch of
 Reedy River on the North Side of said River including the
 Plantation where the said Stout now lives with an Hundred
 and Ten or more in the same more or less beginning on
 a Stake or Rock 3X (an an old Road being the Corner mark
 for the part of the Tract that the said Small Evans sold to
 Lewis T. Arnold) Thence running S 66 E 40 to a Post Oak
 and 3X bounded by Mrs Jungs Land Thence S 30 W 21 to a Stake 3X
 bounded by Mrs. Muck, & Land S 66 88 11 to a Stake 3X Thence S 12 E
 21 to a hickory 3X bounded by James Thompson Thence west
 13 to a Stake 3X near the branch thence to another Stake about
 a Chain to the west Thence N. 30. 84. 25 to a Stake bounded by
 James T. Arnold Thence N. 12. 17. 29. 30 to the beginning together
 with all and singular the rights, manors, hereditaments, and
 appurtenances to the same belonging or in any wise incident
 appertaining to have and to hold all and singular the premises
 above mentioned unto the said James Stout his heirs and
 assigns for ever and I do hereby — myself my heirs, ex. &c. &c.
 and administrators to warrant and for ever defend and
 defend singular the premises above mentioned unto the
 said James Stout his heirs and assigns against myself
 and my heirs and against every person who and so ever
 lawfully claiming or to claim the same or any part
 thereof Witness my hand and Seal this sixth day of
 January in the year of our Lord one thousand eight
 Hundred and thirty five and in the fifty eight year of
 the Independence of the united States of America
