 the said T. Taylor all that tract of land situated in the District and State aforesaid
 on the west of Enoree river containing One Hundred and Ninety nine acres more or
 less being a part of the tract of land one of which was granted to Thos. Taylor
 was purchased of Andrew Sykes another supposed to be Robert Coates was purch-
 -ased by John Southern one of the Executors of Samuel Cradock deceased was conveyed
 by John Southern to Joseph Coleman from Joseph Coleman to Zion Taylor
 the tract was conveyed by Hiram Roberts to said Coleman and from said Coleman
 to said Taylor and these such bounds marks &c. as follows (viz) beginning at a
