 to Robert Wymme which he has paid and advanced to me and for my use have this day
 sold transferred relinquished and assigned to the said Robert Wymme all my right title
 interest and estate in and to the following negroes (viz) Skinny Anarchy and her baby
 and three other children Washington Silla and Melisa Lucy and her two children Baylis
 and Catharine Pallas Carolin and Mary Charles John and Mawel now in the
 possession of my mother Mrs Susannah Wymme my interest and estate in said negroes
 being one fifth of the same and their increase (at my mothers death) And I hereby
 warrant and defend the said interest hereby conveyed in the said negroes to the said
 Robert Wymme to him and his heirs executors administrators and assigns and against
 myself my heirs executors administrators and assigns forever In witness whereof I
 have hereunto set my hand and seal this the 20th day of May A.D. One thousand eight hun-
 dred and forty two
