 Greenville District } by these presents
 that I Archibald R. Richards of Greenville District and State aforesaid for
 and in consideration of the sum of Fifty Dollars to me in hand paid by
 Yardry M. Bee of the State and District aforesaid have this day bargained, sold
 and conveyed unto the said Yardry M. Bee a certain piece or parcel of Land
 which is supposed to be within the lines of a tract of Land owned by the
 said Yardry by a purchase from Lemuel S. Minton & likewise by a grant
 from the State of South Carolina dated 12th day of July A. D. 1831. as appears
 of record. the Land hereby conveyed Begins at a Dogwood f. runs North 110. degrees
 West 20 Chains to a stake thence South 50 West 7 Chains Stake thence N. 62^o
 W. 58. 25. to a stake thence S. 27. W. 24 Ch. thence S. 84^o. E. 58. 25 to the beginning
 supposed to contain about seventy four acres be the same more or less
 the land not being now pretended to be measured as this is a contract
 entirely of compromise & this conveyance made to put an entire stop
 to all altercation hereafter as it is fully known that the said Yardry
 titles covers the same Lands and this is made as an entire quit claim
 to any and all lands that might intersect within the boundary of the
 said Yardry's land either granted to Kerr. C. or Lewis Rector which gra
 were supposed to intersect but if they do intersect this conveyance
 conveys all the land within the said Yardry's boundary & no more
 hereby conveyed to the said Yardry M. Bee his heirs and assigns all
 the entire interest I have or ever had in the above described Land
 from me and my heirs forever but no further as it is only intended
