tion I bear towards my brother Elisha League and his wife Lucinda, and in consideration of divers favours which I have received from them & in consideration of the sum of five Dollars to me in hand, I do hereby give the said Elisha League and his wife Lucinda the Tract of Land whereon We all live containing Twenty one Acres, during their natural lives to live on the same and use it as their own and to enjoy the same as though they owned it in fee simple but after their death to be equally divided between their children share and share alike and I do moreover give all my other worldly effects in the same way after my Just debts & funeral Expenses are paid, this deed, having been executed solely at my request, I want it to bear all the force of relinquishment that deeds of Gift usually do, but nothing herein shall be construed to effect my rights and privileges, so long as I may live to enjoy it. and the true intent of this conveyance and Deed of Gift is that it takes effect after my Death.
