
Varday Mc Bee For 59 Barnett Statham.	Deed For Land.

Witness all men by these presents, That I, Varday Mc Bee in the State aforesaid, for and in consideration of the sum of One thousand four hundred to me in hand paid by Barnett Statham (the rec. whereof is herein acknowledged) in the State aforesaid, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Barnett Statham all that Tract or parcel of Land, situate lying and being in Greenville District, near the village of Greenville on the north side of the Bencombe road, Beginning at a Post oak 3 x 3 x 0 on said Statham & Elias D. Earles corner, & runs thence with said Earles Line, S. 75° W. 13.30 to a W. Oak on the Bencombe Road, thence with said road, N. 23° W. 7.41 to a bend, thence N. 32° W 5.40 to a bend, thence N. 43 1/2° W. 30.25 to a Stake, on said road, thence with said Earles line N. 30 1/2° E. 15.12 to a stone by P. O. Stump, thence with said Earles line & said Stathams line S. 30 1/2° E. 54 chains to the Beginning Containing fifty eight acres two Rods & 20 Poles more or less Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining. To have and to hold, all and singular the Premises before mentioned, unto the said Barnett Statham his Heirs and Assigns forever. And I do hereby bind myself my Heirs, Executors and Administrators, to warrant and forever defend, all and singular the said Premises, unto the said Barnett Statham his Heirs and Assigns, against myself, and my Heirs, and against every person whomsoever, lawfully claiming or to claim the same, or any part thereof.
