Rowland ~~tell that~~ Lot or piece of Land, situate near the Village of Greenville (within the incorporated limits of said village) on the Eastern side of the Augusta Road, Beginning at a Stake 3x in said Augusta Road, & runs thence S. 58° E. 330 feet, to a P. O. 3x. thence, S. 36° W. 198 feet, to a stake 3x thence S. 40° W. 40 feet to a Stake 3x thence N. 50° W. 350 feet to a stake 3x on said Augusta road, thence with said road N. 33° E. 204 feet to the beginning corner, Contain- ing One acre two rods & twenty sixches, be the same more or less.
