

Jones the remaining Heir to said land of Greenville Dist we have granted bargained and sold and by these presents we do grant bargain sell and release unto the said John J. Jones all that plantation or tract of Land where John Jones decd. formerly lived on Peters Creek waters of Enoree River containing Two Hundred acres more or less beginning at a stake 3x on Tho P Brockmans land and runs on said line N 49 1/4 W. 40 chains to a Hickory 3x near a pine marked BK thence on the tract formerly owned by El. C. Shep. yards no. Tho P Brockman S. 30 W. 6 chains to a stake thence N. 70 W 9. 50 to Black Jack. 3x near a P. C. 3x 3x 0, on S. 42 W. 20 chs. to a stake 3x then on Ab. Smiths land due S 14. 50 to a stake by Stones in the Gorman old field then W 79 W. 13 chs to a Black Jack. 3x then on Saml B Hills lines S 40 E. 29. 50 to a P. C. 3x 3x then S 60 E 2. 70 to P C 3x then N. 31 E. 3.
