Jones his Heirs Ex<sup>rs</sup> Adm<sup>rs</sup> &c against ourselves, our Heirs, Ex<sup>rs</sup> Adm<sup>rs</sup> &c. and against every other person or persons whomsoever lawfully claiming the same, or any part thereof.
