

in consideration of the sum of One thousand dollars to me in hand paid by Pascal P. Cureton of the same place have granted, bargained, sold & released and by these presents do grant, bargain sell & release unto the said Pascal P. Cureton all that plantation or tract of land containing three hundred & fifty four acres, more or less, situate & lying in the State & District aforesaid on the South west side of the Reedy Fork Creek, beginning on a small Red oak 3x one near Wilson Ferry road thence along said road S 75 N. 9 chs. thence N 88 W. 25.40 on said road to a stake no w stone 3x one, Thence S 28 E 6 chs. across a small branch to Red oak 3x one. Thence S 30 W. 16 chs to a Hickory Pond. now stone 3x one, Thence S 40 W. 37.80 to a stone 3x one Red oak bush - Thence S 59 E 58 chs to a Black oak 3x one near Farmers Corner, Thence N 43 E. 5.20 to a Post oak 3x one, Thence S 55 E 13.25 to a stake 3x one, by a Post oak - Thence N 30 E 37 to a stake 3x binding on J. H. Joyce's land - Thence N 25 W. 9 - to a Post oak 3x0 on in side field, Thence N 40 W. 23.25 to a small Pine, now stone 3x one, binding on John M. Cureton's land - Thence N 65 W. 3.37 to a sassafras by a stone 3x Thence N 11 W. 16 chs to the Red oak 3x beginning corner, - Together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining to have & to hold all & singular the premises before mentioned, unto the said Pascal P. Cureton, his heirs and assigns forever, and I do hereby bind myself, my heirs, executors, & administrators to warrant, and forever defend unto the said Pascal P. Cureton, all the said premises, and against every other person or persons whomsoever lawfully claiming or to claim the same or any part thereof.
