

J. P. Butler, C. E. & D. To Lawrence Brock.	Deed to Land.

The State of South Carolina.
This Indenture, made the
fourth day of October in the year
of our Lord one thousand eight hun-

dred and forty seven, between J. P. Butler Esquire, Commissioner of the Honorable Court of Equity for Greenville district, at Greenville S.C. in the said State, of the one part, and Lawrence Brock of the other part:

Whereas, R. J. Duncan Esq^r and others on or about the sixteenth day of March A.D. 1847 did exhibit their Bill of Complaint in the Court of Equity, at Greenville S.C. in the said State, against Lawrence Brock, George Brock, John Brock et al. praying for Partition and sale of the Real Estate of Henry Brock dec^d. And the Cause, being up issue before the Honorable Court, came on to be heard at June Term, when the said Court, after full hearing thereof, and mature deliberation in the premises, did Order, Adjudge and Decree, that the said Lands as mentioned in said Bill should be sold at public Auction, by the Commissioners of the said Court, at the terms and for the purposes mentioned in their Decretal Order, as by reference thereto, in the Registry of the said Court, will appear: - And the said J. P. Butler as Commissioner of the said Court, after having duly advertised the said Lands for sale, by public outcry, on the said fourth day of October first above mentioned, did, then openly and publicly, and according to the custom of Auctions, sell and dispose of the said Tracts of Land below described unto the said Lawrence Brock for Twenty two hundred Dollars he being, at that price, the highest bidder for the same. Now, therefore, this Indenture witnesseth, That the said J. P. Butler, as Commissioner of the said Court, under, and by virtue of the said Decree, and in consideration of the sum of Twenty two hundred Dollars secured him by the said Lawrence Brock the receipt whereof is hereby acknowledged, hath granted, bargained, sold and released, and by these presents, doth grant, bargain, sell and release unto the said Lawrence Brock his heirs and assigns, all that Tract of Land, situate lying and being in Greenville District on the waters of South Tyger River just above Thomas Bridge, adjoining Lands of Gilreath, Goodlett and others containing Five hundred and three acres more or less, being a tract sold to H. & L. Brock and recently sold as Lands of Henry Brock dec^d. for Partition - consisting of different tract, having such metes and bounds as is represented by Platts here annexed, one the surveyed by Jas. W. Dickson Sept. 10. 1847, by the same, Sept 11, 1847, and by H. D. Shelkeld 18 March 1848, and a conveyance of Wesley Gilreath 18th Jan'y 1844 - which Platts are attached and is a part of this Deed, and marked A. B. C. & D. - sold by the Commissioner, the day and date above mentioned - Together with all and singular the Accoutments, rights, members, and appurtenances whatsoever to the said Tracts of Land, belonging, or in any wise
