 bargained sold and released and by these presents do grant, bargain, sell, and
 and release unto the said Henry S Henderson All that tract or parcel
 of Land situated in said District on the East side of Rocky Creek
 having the following corners and bounds Beginning at a Stake on
 the East side of Rocky Creek, Thence running S. E. to a Red Oak Thence S. E.
 to a Stone, Thence N. E. to a Red Oak, Thence Eastward to a Post oak
 Thence N. W. to a Red Oak, Thence westward to Rocky Creek Thence down the
 Creek to the beginning corner Being the same tract of Land conveyed by
 Henry Brasher to Brasher Henderson and by the heirs at Law of the said
 Brasher Henderson to myself, Containing One hundred and fifty more or less

Together with all and singular the rights, liberties, tenements, her-
 editaments and appurtenances to the said premises belonging or in anywise incident
 or appertaining Reserving and retaining unto myself for my own use and advant-
 age the entire and complete possession, use and control of all and singular said
 premises during the whole term and period of my natural life and immediately
 upon my decease the possession thereof is to result to the said Henry S Henderson

To Have and to Hold all and singular the premises before men-
 tioned unto the said Henry S Henderson his heirs and assigns forever And I do hereby
 bind myself my heirs executors and Administrators to warrant and forever defend all
 and singular the said premises unto the said Henry S Henderson his heirs and assigns
 against me and my heirs and against every person whomsoever lawfully claiming or
 to claim the same or any part thereof
