Gumtree District the first day of January in
the year of our Lord One thousand eight hundred
and forty nine between R B Duncan Executor of the

will of Henry Brock deceased and Nathaniel O'Fuelle both of the said State and
District Whereas the said Henry Brock deceased, die in his life time sold to the said
Nathaniel O'Fuelle a tract of land estimated to contain Two hundred and Threes
situated on Bucke Mountain creek of Environs for the sum of One hundred Seventy five
Dollars The said Brock gave to the said Fuelle a bond to make the said Fuelle
a warrantee title to the said Land when he the Fuelle fully paid for said land datus
the 4th July eighteen hundred and forty two which was not fully done till since said
Brock's death but on a late resurvey of said land by John Watson Esq said tract
was found to contain but One hundred and thirty four and a half acres, lacking seventy
five and a half acres of the quantity sold, the amount of which in proportion to the
sum to be paid for the whole was deducted from the said Fuelle note the balance being
now paid to said Duncan and Brock being One hundred and Seventy five
dollars

Now this Indenture witnesseth that in consideration of the sum of
One Hundred and Seventy Five Dollars to the said Brock in his lifetime and
to me the said Duncan as executor aforesaid paid by the said Brock to his Executor
aforesaid have, granted, bargained sold and released and by these presents do grant
bargain sell and release unto the said W O Fuelle and his heirs and assigns
forever the aforesaid tract of land containing one hundred and thirty four and a half
acres, and hath such bounds marks &c as follows viz Beginning at a black
Gum 3x near said Bucke Mountain creek Thence S 23^o E 11.⁷⁰ chs to a W oak 3x
Thence S 44^o W 26 chs to a Black Oak 3x Thence W 36 W 16 chs to a
P. O 3x Thence W 44 W crossing said creek 27.⁵⁰ chs to a P. O 3x Thence
W 47 E 30.⁵⁰ chs to a Hickory stump 3x Thence W 72 E 9.²⁰ to a P. O 3x
Thence S 21 E 39 chs to a small Hickory 3x near the beginning corner Thence
N 70 E 70. Licks to the beginning corner Together with all and singular the
rights, members, appendages and appurtenances to the said premises belonging
or in anywise incident or appertaining to have and to hold all and singular the
premises aforesaid unto the said W O Fuelle and his heirs and assigns forever

And I as Executor aforesaid do hereby bind the heirs and legatees of the said Henry
Brock, their heirs executors and administrators to warrant and forever defend
all and singular the said premises unto the said W O Fuelle his heirs and assigns and
the said heirs and legatees and their heirs and assigns against every person whomsoever law
fully claiming the same or any part thereof In Testimony whereof I the said R B Duncan as
Executor aforesaid have hereunto set my hand and seal the day and year above written
