Messina Taylor To Sheriff Wm Mc Goodlett	473 Deed To 165 Acres	South Carolina } State to whom these presents shall come of Messina Taylor Sheriff of Greenville District and State of said South Carolina Whereas by virtue of Summary Writ of Fieri Facias issued out of the Court of Common Pleas held for the District of Greenville on the fourth day of March in the year of our Lord one thousand eight hundred and forty seven at the suit of Chas. Taylor et al. to me directed commanding me that of the goods and chattels, lands and Tenements of Robert T. Richards to pay the sum of Two Hundred and thirty dollars damages and costs I have seized and taken of the lands and Tenements of the said Robert T. Richards all that certain piece parcel of Land containing more or less One Hundred and Sixty five acres situated and being in the District of Greenville adjoining lands of James Talley, Thomas Whites et al. being the one half of a Tract of Land containing Three Acres and thirty acres conveyed by Hartwell Richards to Hartwell L Richards and
