to in hand paid by George W Green, the receipt whereof is hereby acknowledged have  
granted bargained, sold and released and conveyed and by these presents do grant  
bargain sell and release and convey unto the said George W Green his heirs and  
assigns all that Tract or plantation of Land situated lying and being in the  
District and State aforesaid, between and bounding on the Wuthufur road on the  
East side and the Buncombe road on the West side Beginning at a Rock  
corner near E. Q Carter Thence N 43 E. 1.50 to a black oak Thence E. S. 25 to  
a Stake on the Wuthufur Road and Thence along and with said road in a  
N. E. direction 27.20 to a Stake Thence N 65. W 27.25 to a Stake Thence S 45  
W 13.10 to a Stake E. Q Carter corner Thence N 36 W 15. to a rock Thence S 80  
W 15.12 to a Stake on the Buncombe road near E. Q Carter ditch Thence along  
said road S 43 E 30.25 to a Stake Thence still along said road S 32 E  
S. 25 E to a white oak on the Buncombe road Thence N 75 E 13.50 to the  
beginning corner Containing One Hundred and Thirt eight and one half  
acres more or less Bounded on the East by O. C. Stover land and E. P. Gray  
land and North East by lands of My husband, North by lands of E. H.  
Carter and west by lands of W. M. See and South by E. H. Carter, residence  
being the place where I now live

Together with all and singular the rights, memory  
and hereditaments and appurtenances to the said premises belonging or in any  
wise incident or appertaining To have and to hold all and singular  
the premises before mentioned unto the said George W Green his heirs and  
assigns forever and I do hereby bind myself my heirs, Executors and Ad-  
-ministrators to warrant and defend forever all and singular the said  
premises unto the said George W Green his heirs and assigns against  
myself and my heirs and against every person whomsoever lawfully claiming  
or to claim the same or any part thereof
