Released Conveyed and Confirmed and by these Presents does Grant Bargain Sell
Release Convey and Confirm unto the said Sarah Satterfield her heirs and assigns
all that lot being a parcel of Land situated lying and being in the District of
Greenville State of South Carolina about one mile from Greenville town thereon con-
taining one acre more or less. Further by the said Ann Satterfield of Edward Montg-
omery residence being had to said Quid it will more fully appear also the tract a piece
of Land situated lying and being in the aforesaid District of Greenville and State of South
