 or parcel of Land situated lying and being in said District Beginning on  
 a Stake on Westmeadows Line 7.45 on said Line to a Tichenry 37 Thence on that  
 same Davis Line to a Post oak bush 7.45 Thence to the beginning corner the  
 whole to contain Two Acres of Land Together with all and singular the rights  
 members hereditaments and appurtenances to the said premises belonging or in  
 anywise incident or appertaining

To have and to hold all and singular the premises before mentioned  
 unto the said Wm Goldsmith his heirs and assigns forever and I do hereby bind  
 myself my heirs Executors Administrators and assigns to warrant and  
 forever defend all and singular the said premises unto the said William Goldsmith  
 his heirs and assigns against myself my heirs and against every other person or  
 persons whomsoever lawfully claiming or to claim the same or any part thereof In Wit-  
 ness whereof I have set my hand and seal this the Eighteenth day of September in the year  
 of our Lord one thousand Eight hundred and forty nine and the seventy fourth year of the
