 of the Creek Thence S 4 E 10.10 to Rock 34 in old cut Thence on Bartlet's line  
 N 70 E 53.30 to a white oak 34x34 Thence N 45. W 60 to White oak on the bank of  
 the creek Thence up the meanders of said Creek to the beginning corner

Together with all and singular the rights, members, tenements  
 and appurtenances to the said premises belonging or in anywise incident or appertaining
