a plat of the same Ground aforesaid made by Samuel Moore Esq. At or 11th 1849
title where in said Land to rest in the said Elias Chapman after my death and I
hereby reserve to myself the possession use and enjoyment of said Land for and during
my natural life hereby commanding and agreeing with the said Elias Chapman to sell
and transfer the title estate in said Land to the intent that he may have and enjoy the abso-
lute title to the same at the termination of the life estate which is reserved of the
Land

Together with all and singular the Rights Privileges Remittances and
Appurtenances to the said Premises belonging or in any wise incident or appertaining
or appurtenant.

To have and to hold all and singular the Premises before mentioned
beginning with the said Elias Chapman after my death to him and his heirs and assigns forever
and giving unto me I do hereby bind myself and my Heirs Executors and Administrators to warrant
and defend all and singular the said Premises unto the said Elias Chapman
and his Heirs and assigns against me and my Heirs and against every person whomsoever
and for ever claiming or to claim the same a full right title of
