Provided Always nevertheless and in the time intent and
meaning of the parties to these presents that if the said Thomas Chandler
or his Executors or Administrators shall well and truly pay or cause to
pay unto the said Benjamin F. Goodlett his Executors, or Administrators,
the sum of Thirty Three Hundred Dollars, of us and in the respects
aforesaid. Together with all interest that may accrue thereon
according to the True sealed note above mentioned, thus and from thenceforth
no these presents shall be wholly null and void, any thing therein contained
to the contrary thereof, in any wise notwithstanding.

And it is covenanted and agreed especially and between
parties to these presents that until default shall be made in payment of
such sum, as before set forth, and the interest for the same it shall and may
be lawful to and for the said Thomas Chandler peaceably and quiet-
ly to hold, use, occupy, possess, and enjoy all and singular the premises
so granted and released and every part thereof with the appurtenances as
and receive and take the rents issues, profits, thence to his own partic-
ular use and benefit, every thing herein contained to the contrary hereof in
anywise notwithstanding.
