between
Guenville District made this 6th day
of November in year of our Lord one thousand

eight hundred and fifty two between A D Crook
on the one part and Jim G Green on the other part Witnesseth that whereas the
said Jim G Green stands indebted to the said A D Crook in the sum of
one thousand dollars on a sealed note dated November sixth eighteen
fifty two due one day after date with interest payable annually
and in consideration of the said debt a sum of One Thousand dollars
able as appraisers to the said A D Crook according to the tenor and effect of the
appraisers and also in consideration of the sum of one dollar to the said Jim
G Green in hand paid by the said A D Crook and truly acknowledged by
the sealing and delivery of these presents, Do bargain, grant sell and release
and confirm unto the said A D Crook his heirs and assigns forever
certain Tracts of Land situated in Guenville District on the one side
Needy River. The first containing Four hundred and fifty four (454) acres
more or less being the Tract of Land conveyed by Stephen Phillips to the
said Jim G Green in the year Eighteen hundred and fifty one The said Tract is
composed of Five different Tracts to wit the tract which Stephen Phillips purchased
of Marshall Harkness, containing Two hundred Acres more or less The
said Tract adjoins Lands of O P Phillips, Martin Jim Phillips, Needy
River, Isaac A. Paton & Thomas Roe deceased. 2^d Tract one hundred
and sixty three (163) acres adjoining the former tract and purchased by Stephen
Phillips from Absalom Paton. This Tract adjoins one formerly belonging to
Daniel Simmons and that formerly owned by L H Green and the place where
Major Mason once lived and the Lands of the aforesaid Thomas Roe and
3^d Tract containing eight acres purchased by the said Stephen Phillips from
Daniel Simmons. 4th Tract containing Eighty two acres which Stephen
Phillips purchased from O P Phillips adjoining the foregoing Lands and the same
once owned by Andrew Bridges. 5th Tract containing one and one fourth acres
which Stephen Phillips purchased from Jim G Green all of which said Tracts are
in full description of which may be seen by reference to the deed of conveyance
of the said Stephen Phillips to the said Jim G Green

The other Tract intended to be mortgaged and conveyed by this inden-
ture is also composed of several tracts and called by Jim G Green his old place
1st The place which Lucy H Green conveyed to said Jim G Green containing one hundred
and one seventy three (173) acres being the place that Salmon once owned and lies
in situated South and West from the Tract of Four hundred and fifty four (454)
acres herein before mentioned and adjoins Lands of W Choice Esq on the North and to
of the Estate of Thomas Roe on the South the aforesaid Four hundred and fifty
four (454) acre tract on the North and East and by the Lands of Lucy H Green and
Jackson Green and Madison Green on the West. A more particular
