 containing *Eighty* acres be the same more or less situated situated lying and
 being in the State and District of said State on the waters of *South Pickett River*
 and the North side of said River beginning on a stake a conditional line
 between *Jacob Lindsey* or *Abraham Gosnell* thence to a corner thence to a
 Spanish Oak thence to a Holly white oak thence to an old *Blasmer* thence
 to the original as the marks run thence to a stake thence North 17 degrees
 East to a stake to be beginning it being a part of the old *Simple* tract
 of land lying on *Wesley Mountain*

To have with all and singular the rights and number
 and appurtenances to the said premises belonging in any wise in law
 to have and to hold all and singular the premises being
 mentioned unto the said *Peter Gosnell* his heirs and assigns forever and I do
 hereby certify myself my heirs Executors and administrators to warrant and
 defend the said premises unto the said *Peter Gosnell* his heirs and assigns
 against myself my heirs Executors and administrators and against
