Know all men by these presents that I Alman Granshaw of Greenville District in the State of said in consideration of One Thousand and fifty Dollars to me paid by Rev Whiteford Smith of Greenville District in the State of said have granted, bargained sold and released and by these presents do grant bargain sell and release unto the said Rev Whiteford Smith all that piece parcel and tract of Land containing One Hundred and five Acres more or less Situate lying and being in the District and State of said upon the western side of the White House near adjoining lands of McClanahan Hunt, Elijahs and others and having the following bearings and boundaries viz beginning at a Chestnut stump 370 m on the said White House road and running thence with said road 24 chains 42 links to a rock 37 1/2 m thence S. 71 W 36 chains to a White Oak 37 1/2 m thence S 11 E 38 chains 23 links to a rock 37 1/2 m thence N 48 E 36 chains 32 links to the beginning said tract having been conveyed to me by William Hunt

Together with all and singular the Rights Members Hereditaments and appurtenances to the said premises belonging in any wise incident or appertaining To have and to hold all and singular the premises before mentioned unto the said Rev Whiteford Smith his Heirs and assigns forever And I do hereby bind myself my Heirs Executors and Administrators to warrant and firm defend all and singular the said premises unto the said Rev Whiteford Smith his Heirs and assigns against me and my Heirs and against every other person whatsoever lawfully claiming or to claim the same or any part thereof
