 all that piece parcel or tract of land lying and being in  
 the District and State aforesaid on Beaver Dam Creek  
 waters of South Tyger beginning on a Chestnut down, I L West  
 -moreland corner running S 85 E 29.18 chs to a Stone & new thence  
 S 9 W 27.63 chs to white O 3+3+ new thence N 67 W 15.00 chs to  
 white O 3+3+ new thence N 5 E 3.10 chs P. O 3+3+ new thence Due East  
 16.97 chs to Pine Knov 3+3+ new thence N 15 E 22.10 chs to the begining  
 corner containing Seventy acres more or less adjoining lands  
 of John L Westmoreland and others. Together with all and  
 singular the rights members hereditaments and appurtenances  
 to the said premises belonging or in any wise incident  
 or appertaining. To have and to hold all and singular  
 the premises before mentioned unto the said James W  
 Green his heirs and assigns forever, and I do hereby
