 Ninety six dollars and twenty five cents to me paid by Thomas  
 Hopkins of the said State and District aforesaid have granted  
 bargained sold and released and by these presents do grant bargain  
 sell and release unto the said Thomas Hopkins a tract of one hundred  
 and twenty two and a half acres of Land more or less situate lying  
 and being in the District of Greenville and State aforesaid on the  
 head branches of the South Reedy Fork of Reedy River and being  
 composed of two tracts adjoining each other one containing  
 One Hundred three and a half acres bounded as follows. Beginning  
 at a white oak & thence S4 W57 chs to a Hickory & thence S85 E30  
 chs to a white oak & thence N5 E50 chs to a Stake & thence N85 W12  
 50 chs to the beginning corner. The other tract contains Nineteen acres  
 and is bounded as follows. beginning at a Stake & N5 E42 chs to a  
 Stake & thence N63 W10 chs to a Pine & thence S6 E47.25 chs to the  
 beginning corner. both tracts containing one hundred and twenty  
 two and a half acres more or less and bounded by lands of Mr.  
 Jane Moon Josiah Chandler Irvin Hopkins and Artimus H. Smith
