Beginning at a point in the middle of the road and opposite
to a stone Stake which is at the corner of the fence which separates
the said tract from the lot on which said Manly now resides
and resides thence S 5 E 13 ch 37 $\frac{1}{2}$ L thence N 80. 866 L thence S 65 $\frac{1}{2}$ E
1 chs 67 L thence due north to a stone Stake at the garden fence
thence Eastward about twenty five feet to a stone Stake at the
corner, thence Northward in a straight line to a point in the
middle of the road opposite to a stone Stake at the corner of the
fence and thence to the beginning corner together with all and
singular the rights members hereditaments and appurtenances
to the said premises belonging or in anywise incident or app-
ertaining. To have and to hold all and singular the premises
