Know all men by these presents that I John Crittenden in the State and District aforesaid in consideration of the sum of Six thousand One hundred and thirty Dollars to me paid by George M Chaplin of the same State and District have granted bargained sold and released and by these presents do grant bargain sell and release unto the said George M Chaplin all that tract and parcel of land, situate lying and being in the District of Greenville and State aforesaid on the waters of Hickland Creek and on both sides of the road leading to Rutherford North Carolina and containing three hundred and one & one-half acres more or less and bounded as follows beginning at a Stake on Thordon Thompsons line at the base of the hill on the south side of the Creek running thence North 58 chains 58 Links to a Stake near a Spring thence East 58 Links to a Stake thence N 5 W 6.58 links to a Sweet Gum near the road thence S 71 W 0.5 chains with the road to a Stake on old line 34 thence with the old line N 10 E 36 chains to a Post oak 34 thence west 30 chains to a Stake thence S 30 W 45 chs to a Stake thence S 70 E 27 chs 50 links to a Stake 34 thence S 11 E 11 chains to Stake thence S 45 W 0.7 chains 76 Links to a Bass afra 34 thence S 40 E 5 to Stake thence S 6 W 2 chains 69 Links to Stake thence S 35 E 4 chs 85 Links to Stake 34 thence S 3 E 7 chains to Thompsons line at the base of the hill thence S 85 E 15 chains to the base of the hill thence S 45 E 13 chains 50 links to Stake thence S 55 E 2 chains to the beginning it being part of a tract of land I bought of Jeremiah Cleveland by deed bearing date the thirteenth day of October 1839.
