 Know all men by these presents
 that I Alexander McBee of Greenville

District in the State aforesaid in consideration of Nine
 Hundred and fifty four Dollars to me paid by A W G Davis
 of Greenville District in the State aforesaid have granted
 bargained sold and released and by these presents do grant
 bargain sell and release unto the said A W G Davis all
 my right title and interest in and to all that tract or
 parcel of land situate in Greenville District containing three
 Hundred and twenty five acres more or less adjoining lands
 granted to Wilson Barton Joseph Goodwin and others on
 both sides of Fall Creek waters of Saluda River and more
 particularly described by plat in Location Book D D page
 5. and surveyed on the 25th day of April 1846 by W R Hightower
 for Alfred Hightower, as conveyed to me by W H Thomas Com-
 missioner in Equity for Greenville District in the sale made in
 the cause of Masena Taylor Administrator of all and singular
 the goods chatties rights & credits of John W Hedges deceased
 against Caroline Hedges et al for the sale of the real estate of
 John W Hedges, and also excepting and reserving from this
 land fifteen acres thereof by me deeded to W A Townes Trustee
 for Caroline Bayne wife of William Bayne bearing date 18th
 day of October A D 1861 - Together with all and singular
 the rights members hereditaments and appurtenances to the
 said premises belonging or in any wise incident or appertain-
 ing. To have and to hold all and singular the premises before
 mentioned unto the said A W G Davis and his heirs and assigns
 forever. And I do hereby bind my self and my heirs executors
 and administrators to warrant and forever defend all and
 singular the said premises unto the said A W G Davis and
 his heirs and assigns against me and my heirs and every
 other person whomsoever lawfully claiming or to claim the
 same or any part thereof as granted to me by said conveyance
 but not to obligate me any further
