

Creek branch waters of South Tyger river begining on a Stake in the path leading from the house to the mill on north side of branch thence S^WE to a chestnut above the Spring thence N⁵⁹ W⁰ 14.90 chs to chestnut 3⁴ on Tillys corner thence N¹⁸ E^{9.25} chs with Tillys line to a Stake on Rodes line thence S³⁸ E^{9.13} chs with Rodes line to Spanish oak 3⁴ on the bank of said Meadow creek Rodes and Middletons corner thence to the begining corner to Comptons line north side of Meadow fork Mash creek begining on a Spanish oak on the south side of said branch thence north with C Rodes line to a black gum thence east a conditional line to Bensons mill path to a Stake on C Comptons and to Bensons line thence south to a chestnut at mouth of Rodes Spring branch thence west with meanders of said Mash Creek to the begining C Comptons deed to T Bensons on north side of Meadow branch begining on a Stake in the west corner of C Comptons old field W D McMakinis and T Bensons corner on T Bensons mill path thence East a conditional line to a rock on C Comptons W D McMakinis and T Bensons line thence N E with said line to a corner on Alfred Turners and C Comptons line an agreed corner thence west to a rock near the ford of the branch in the field an agreed corner thence S^WE to the begining corner C Rodes line begining on a Spanish oak on the south side of the Meadow fork thence north with C Comptons line to a Stake in the S^E corner of C Rodes old field thence west in the old field to a lower wood in the S^WE corner of said old field thence S^WE to a Stake on Mr Tillys near an old house place thence S^E with Mr Tillys line to the begining corner C Comptons lines begining on a black gum T Bensons and C Comptons line an agreed corner thence E to a Stake on C Comptons and T Bensons line on agreed corner thence S with said line to a white oak an agreed corner thence E to a Stake on C Comptons and T Bensons line an agreed corner thence S^WE to a Stake in west corner of the old field W D McMakinis and T Bensons and C Comptons corner thence west with mill path to the begining corner.
