 stake in the path leading from the house to the mill on
 north side of branch thence S W to a chestnut above the
 Spring thence N 59 W 14.90 chs to chestnut 34 on Lillys corner
 thence N 18 E 9.25 chs with Lillys line to a stake on Rodes
 line thence S 38 E 9.13 chs with Rodes line to Spanish oak 34 on
