 To For Know all men by these presents  
 Wm Mc Thomas adm Land that I Benjamin F Brockman  
 of Spartanburg District in the  
 State aforesaid for and in consideration of the sum of Eight  
 Hundred dollars to me paid by Wm Mc Thomas administrator  
 with the will annexed of Joseph A Legion deceased of Green-  
 ville District in the State aforesaid and Five Hundred  
 Dollars to Martha Jane Hawkins to whom I formerly gave  
 a Bond for titles to this land which is now cancelled, have  
 granted bargained sold and released and by these presents do grant  
 bargain sell and release unto the said William Mc Thomas Commissioner  
 in Equity for Greenville District and Administrator of and with  
 the will annexed of Joseph A Legion deceased all that tract  
 or parcel of land situate lying and being in Greenville  
 District in this State commencing on a white oak corner  
 on the branch to a Stake on the Spartanburg Road thence  
 along said road to a rock on the west corner of Coopers  
 fence thence along said fence to a Holly on Bishop's line  
 thence along said line to a rock corner in the old field  
 or a Sicomon in said old field thence along said road  
 to the beginning corner on the branch, being the land  
 I formerly sold to Mr J Hawkins and gave her my bond for  
 titles, which Bond she has assigned to Wm Mc Thomas as  
 above set forth and ordered me to make titles to him or  
 his order. Together with all and singular the rights premises  
 hereditaments and appurtenances to the said premises belonging  
 or in any wise incident or appertaining. To have and to hold all  
 and singular the premises before mentioned unto the said Wm Mc  
 Thomas Commissioner in Equity and Administrator of  
 Joseph A Legion deceased according to the terms and con-  
 ditions of the will of said Joseph A Legion and his heirs  
 and assigns forever and I do hereby bind myself and  
 my heirs executors and administrators to warrant and  
 forever defend all and singular the said premises unto the  
 said William Mc Thomas and his successors in the trust  
 above set forth and their heirs and assigns against me  
 and my heirs and every one else lawfully claiming or to  
 claim the same or any part thereof. Witness my hand and  
 Seal this day of September in the year of our Lord one thou-  
 sand eight hundred and sixty three and in the Eighty eighth  
 year of the Independence of the State of South Carolina
