 and State aforesaid have grabled bargained sold and released
 and by these presents do grant bargain sell and release unto
 the said James Gosnell a certain piece parcel or tract of land
 containing one hundred and two acres be the same more or less situate
 lying and being in the District and State aforesaid lying on the head
 waters of North Saluda River, it being part of a survey granted to
 James Williams and bounded as follows, Viz, Beginning at a Stake
 on Gosnells line running N29 E 20 chains to a Stake thence S70 W
 73.50 chains to a Stake on James Wards line thence with said line
 S9 E 10.45 chains to a Stake thence S66 E 5.60 chains to a black oak on
 James Gosnells line thence with said line N70 E 62 chains to the begining
 corner, Together with all and singular the rights members hereditaments
 and appurtenances to the said premises belonging or in any wise incid-
 ent or appertaining to have and to hold all and singular the premises
 belonging or otherwise incident or appertaining to have and to hold
 all and singular the premises before mentioned unto the said
 James Gosnell his heirs and assigns and I do hereby bind myself
 my heirs Executors and administrators to warrant and forever defend
 all and singular the said premises unto the said James Gosnell
 his heirs and assigns against myself my heirs and against every
