of the sum of seventy dollars paid to me in hand by Dr Basil Manly of Greenville District and State aforesaid have granted bargained sold and released and by these presents do bargain grant sell and release unto the said Dr Basil Manly all that tract or parcel of land situated in Greenville Dist: State aforesaid containing about one and three quarters a crees more or less, this tract is composed of a portion of one acre that the said Henry R Williams recently purchased of Dr Tho J Liles and a slip cut off of the west side of the said William Anderson tract and is bounded on the west side by the original line of the said Anderson tract thence down a plank fence East course on line of same tract to a Holly Bush Near the junction of two Branches thence South ~~thing~~ of about the course to a corner, thence East of South a short distance to Stone, thence a west course to a Stone corner on the original line these lands are bounded on the west by lands of Nech on the north by lands of the Estate of Col J S Coleman Estate by the lands of the said Henry R Williams and on the South by lands of the said Dr Basil Manly, the Exact courses and distances is not known but the lines as agreed upon is clearly defined by the Lines and courses as has been described

Together with all and singular the rights members hereditaments and appurtenances to the said premises or in anywise incident or appertaining to have and to hold all and singular the premises before mentioned unto the said Dr Basil Manly his heirs and assigns forever and I do hereby bind myself my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said Basil Manly his heirs and assigns against me my heirs and against all other persons Lawfully claiming or to claim the same or any part thereof,

As witness my hand and Seal this the 25th day of December in the year of our Lord one thousand eight hundred and sixty one and in the first and second year of the Independence of the Confederate States of America, Signed Sealed and delivered in the presence of J J McDaniel L Watson 3 Henry R Williams
