 have given granted and released and by these presents do  
 give grant and release unto the said Warren B Hunt Two

 heirs and against every person or persons whomsoever lawfully claiming  
 or to claim the same or any part thereof. Witness my hand and seal this the  
 Fifteenth day of August in the year of our Lord One thousand Eight hundred  
 and Sixty three and in third year of the Independence of the Confederate States  
 of America - signed sealed and delivered in the presence of
