District in the aforesaid State in consideration of Four thousand Dollars to me paid by James P Boyce L.L. of Greenville District in the State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said James P Boyce two parcels or tracts of land formerly a portion of the real estate of the late John T Coleman decr, situated near the town of Greenville in the said District and State and bounded as follows Viz, The first Beginning at a Stake in the middle of the road corner of lots No 5 & 6 running thence S 83 E between said lots 18.32 chs to a Stake 34 in the line of J W Brooks hence along said line S 88 8 chs to within 16 1/2 feet of the line of a Stake, thence parallel with said line leaving of W 4 Brooks a right of way 16 1/2 ft wide, S 61 1/2 W 15 chs to a stone near large B.O. thence along the Augusta road N 53 1/2 W 6.92 chs to the middle line of New road thence along said middle line N 7 E 13 00<sup>ds</sup> to the place of beginning and containing twenty four acres more or less, The second lying south of the Augusta Road Beginning at a Stake on the said road at the corner of the lot sold to E Earle running thence S 31 1/4 W 16.63 chs to a Point 34 hence S 73 8 1/2 E 62 chs to a stone 34. thence N 19 E 13.15 to stone near large B.O. on the Augusta Road thence along said road N 53 1/2 W to the place of beginning and containing fifteen acres three rods and Eight poles together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
