 and released and by these presents do grant bargain  
 sell and release unto the said Martin Hunt jun all that  
 piece parcel or tract of land situate lying and being in Green  
 ville District and State of South Carolina on both sides of Armstrongs  
 Creek Branch Waters of Saluda containing One Hundred and  
 ten acres by the same more or less Beginning at Gum Sapling  
 on the East Bank of Armstrongs Creek thence along a fence to a  
 Red Oak Sapling thence a straight line to a Red Oak near William  
 Martins Original corner thence Martin Hunt jun thence along  
 said line to a Post Oak corner thence said line to conditional  
 line between George Bradley and Gedance Bradleys now Martin  
 Hunts corner to Armstrongs Creek thence a conditional line between  
 George Bradley and Abraham Bradleys, to a conditional line  
 between Abraham Bradleys and James Bruce, thence along  
 said line to conditional line between George Bradley and Thomas  
 Hooper thence said line to a conditional line between George  
 Bradley and George Evans, thence said line to a Maple on the  
 West Bank of Armstrongs Creek thence to the Beginning  
 together with all and singular the rights members hereditaments  
 and appurtenances to the said premises belonging or in anywise
