McBee of the Village of Greenville in the aforesaid State in consideration of the sum of Six thousand and sixteen Dollars to him in the State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Vardry McBee his heirs Executors Administrators & assigns a certain tract or parcel of land lying and being in the Town of Aiken in the District of Barnwell State aforesaid Beginning at a Stake 3<sup>rd</sup> corner of York and South Boundary Street and runs thence <sup>along</sup> York Street 300 feet to a Stake 3<sup>rd</sup> corner of a lot belonging to G. B. Lythgo Esqr thence with the line of his lot 300 feet to Fairfield Street thence with Fairfield Street 300 feet to South Boundary Street, thence with South Boundary Street 300 feet to the beginning corner at York Street containing two acres and ten poles more or less. Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining to have and to hold all and singular the premises before mentioned unto the said Vardry McBee his heirs and assigns forever and I do hereby bind myself & my heirs Executors and Administrators to warrant and forever defend all and singular the said premises unto the said Vardry McBee his heirs and assigns against me and my heirs and against every other person or persons lawfully claiming or to claim the same or any part thereof - Witness my hand and seal this 2<sup>nd</sup> day of August in the year of our Lord one thousand eight hundred and sixty and in the Eighty fifth year of the Sovereignty and Independence of the United States of America, signed sealed and delivered in the presence of H.
