 said Street N 22 W 272 1/2 feet to a Stake 3+ on a Street parallel
 to Pendleton Road thence N 68 E 150 feet to a Stake 3+ thence
 S 22 E 272 1/2 feet to a Stake on Pendleton Road thence with
 said Road S 68 W 150 feet to the beginning. Together with
 all and singular the rights members hereditaments and
 appurtenances to the said premises belonging or in anywise
 incident or appertaining. To have and to hold all and singular
 the premises before mentioned unto the said Alexander Mc-
 Bee his heirs and assigns forever and I do hereby bind my
 self my heirs executors and administrators to warrant and
 forever defend all and singular the said premises unto the
 said Alexander McBee his heirs and assigns against
 my self and my heirs & against any person lawfully claim-
 -ing or to claim the same or any part thereof. Witness
