I do have      and to hold all and singular the premises before mentioned unto the      said Robert G Whitman his heirs and assigns forever) and I do hereby      bind myself my heirs Executors and Administrators to warrant and      forever defend all and singular the said premises unto the said      Robert G Whitman his heirs and assigns against me and my heirs      and any person whomsoever lawfully claiming or to claim the same      or any part thereof.
