To have and to hold all and singular the said undivided half interest unto the said The Greenville and Columbia Railroad Company its successors and assigns forever, and in further consideration of the premises and of the fact that the said part of the Greenville and Columbia Railroad Company has for its object, amongst other things, to declare the manner in which said connecting track shall be used by said Railway Companies: Now it is mutually agreed between the said The Atlanta and Charlotte Air Line Railway Company and the said The Greenville and Columbia Railroad Company, that from the date of the execution of these presents, the parties hereto and their agents are not to use the said connecting railway and property appurtenant thereto for the purpose of either receiving, storing or delivering any local freight destined for or carried from the City of Greenville, but that said connecting road, its franchises and easements and property appurtenant thereto shall be used solely and exclusively for the transfer of through freights and passengers from each of said roads to the other. Provided, that the parties to these presents may by mutual agreement provide for any use of said connection hereafter as they may see proper.
