bargain sell and release unto the said Augustus Huff a certain lot or tract of land lying and being in the County and State aforesaid in Fairview Township fourteen miles south of Greenville City, or Reedy River containing seventy six acres bounded by my own lands and land of Augustus Huff it being a portion of the tract of land deeded to P D Huff by Philenon Huff for his three sons viz Jas W, Augustus and F B Huff and then conveyed to me by Jas W Huff. Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in any wise incident or appertaining to have and to hold all and singular the said premises before mentioned unto the said Augustus Huff his heirs and assigns forever, And I do hereby bind my heirs executors and administrators, to warrant and forever defend all and singular the said premises unto the said Augustus Huff his heirs and assigns, against myself or my heirs and every other person lawfully claiming or to claim the same or any part thereof.
