 release unto the said J. A. Hendrix all that lot or parcel of land
 lying and being in the western portion of the City of Greenville on
 S.W. side of Reedy River beginning at a stake Myers N.W. corner
 thence with said Myers line 130 ft to stake on River Street
 thence with said street 70 ft to Pittman's corner thence with said
 Pittman's line one hundred and thirty five ft to a stake on said
 line, thence straight to the beginning containing eight hundred sq ft
 more or less and bounded on E by River street on N by Pittman's
 lot on W by said Reeses' and on S by the Myers lot.
 Together with all and singular the rights members hereditaments
 and appurtenances to the said premises belonging, or in anywise incident
 or appertaining. To have and to hold all and singular the premises
 before mentioned unto the said J. A. Hendrix his heirs and assig-

 having the following lines, metes and bounds, to wit: Beginning
 at a stake on Buncombe street and running thence with said

 to a stake, thence S. 27 1/2 E 118.7 feet to a stake, thence N. 9
 W 74.10 feet to a stake Mrs S. J. Wells corner and thence S. 29
