Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said Lucinda Budduth and her heirs and assigns forever and we do hereby bind ourselves and our heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said Lucinda Budduth and her heirs and assigns against us and our heirs and against every person whatsoever lawfully claiming or to claim the same or any part thereof
