The State of South Carolina
Know all men by these presents
that I Hewlet Sullivan of
Greenville County in the State

of said, in consideration of the sum of three hundred
and fifty Dollars to in hand paid at and before the
reading of these presents, by Endora Shumate of Greenville
County in the State aforesaid, & the receipt whereof is her-
by acknowledged, have granted, bargained, sold, released
and by these presents do grant, bargain, sell and release
unto the said Endora Shumate, all that piece parcel and
tract of land situate lying and being in Greenville County
South Carolina, containing one hundred and nine
acres more or less, being that portion of the lands of James
H Hopkins deceased, deeded to said Endora Shumate by
the other heirs at law of said James H Hopkins deceased, and
purchased by me at Sheriff's sale under an execution on a
Judgment against the heirs at law of said James H Hopk-
kins deceased obtained on a debt of said James H Hopkins
together with all and singular the rights, members, heredit-
aments and appurtenances to the said premises belong-
ing, or in anywise incident or appertaining, To have and to
hold all and singular the said premises before mentioned
unto the said Endora Shumate, her heirs and assigns
forever, And I do hereby bind myself, my heirs, exec-
utors and administrators, to warrant and forever
defend all and singular the said premises unto the said
Endora Shumate, her heirs and assigns, against me and
my heirs, lawfully claiming, or to claim the same or
any part thereof.

seventy nine and in the one hundred and fourth year
of the sovereignty and Independence of the United States of
America.

presents that I F D Farmer of

the State and County aforesaid for and in consideration of
the sum two hundred Dollars to me in hand paid by
Perry B Moore of the State and County aforesaid have this
day bargained, sold and released and by these presents do
grant, bargain, sell and release unto the said Perry B Moore
a certain tract piece or parcel of land lying and being in
the State and County aforesaid on the branch waters of
Middle Tyger river beginning on James Howards stone
corner on the Greenville Road near New Tenters spring
thence Eastward with said Road to the Glassy Mountain
Church house lot line thence Southward with said line to
a stone corner being the Church lot and Joseph Ballenes
corner thence with said Ballenes line Southward to a
stone corner on a branch on John Fishers corner thence
Westward with the meanderings of said branch to a
white Oak being B E Chestnuts corner and thence Northward
with said Chestnuts to a white oak, the said Chestnuts corner
thence Southward with the said Chestnuts to a black Oak
thence west with said Chestnuts line to James Howards Chest-
nut corner on the aforesaid line thence Northward with
the said James Howards line to the beginning corner containing
fifty acres more or less Together with all and singular
the rights, members, hereditaments and appurtenances belong-
ing to the same or anywise incident or appertaining to the same
or any part thereof, I the said F D Farmer of the State and
County aforesaid bind myself, my heirs, executors, admini-
strators and assigns to to warrant and forever defend all and
singular the said premises to the said Perry B Moore his
heirs, executors, administrators and assigns against me my
heirs, executors, administrators and assigns against any other
person or persons whomsoever lawfully claiming or to claim
the same or any part thereof, whereunto I have set my
hand and seal this October the eighteenth day of in the
year of our Lord one thousand eight hundred and seventy
nine.
