Know all men by these presents  
that I E. A. Carter of Green-  
ville County in the State

aforesaid, in consideration of the sum of Seventy five  
Dollars to me paid by Mathew Carter and Catherine  
Carter in the State aforesaid, have granted bargain-  
ed sold and released, and by these presents do grant  
bargain sell and release unto the said Mathew Carter  
and Catherine Carter a certain piece and parcel of  
land lying and being in the State and County afores-  
aid containing about ninety acres or less adjoining  
lands of John Simmons Dock Marshallbanks Gallaus  
and others it being the same tract of land on which  
the said Mathew Catherine Carter have lived for  
over forty years and it being the same tract of  
land deeded to me by Mathew & Catherine Carter we  
having by mutual consent agreed to not carry  
out the conditions of their deed to me and for  
that reason I by this deed convey to them the  
said tract of land and for the consideration above  
mentioned. Together with all and singular the  
rights members hereditaments and appurtenances  
to the said premises belonging or in any wise  
incident or appertaining. Do have and to hold  
all and singular the said premises before men-  
tioned unto the said Mathew Carter and Cath-  
erine Carter their heirs and assigns forever, and  
do hereby bind myself my heirs executors and  
administrators to warrant and forever defend  
all and singular the said premises unto the  
said Mathew Carter and Catherine Carter their  
heirs and assigns against me and my heirs, or  
every other person whatsoever lawfully  
claiming or to claim the same or any part  
thereof.
