Keuff and Newell Sullivan and contains (42) one hundred and forty two acres more or less Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining To have and to hold the same all and all and singular the said premises before mentioned unto the said estate of Jarrett Yeargin dead his heirs executors administrators and assigns forever and we do hereby bind our heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said Estate of Jarrett Yeargin dead his heirs executors administrators and assigns against us and our heirs and every other person or persons whomsoever lawfully claiming or to claim the same or any part thereof.
