Dollars to me in hand paid by Jesse W. Cannon
of Greenville County in the State aforesaid, have
granted bargained sold and released and by these
presents do grant bargain sell and release unto
the said Jesse W. Cannon a certain piece parcel
or lot of land known as lots No 7th & 8th as surveyed
by James K. Dickson for W. A. Heill December
13th 1880 located on the North West corner of
Emma Street and New Street in the town of Green
County of Greenville and State of South Carolina
Beginning at a stone 3x on said corner running S 15th
W 200 feet to a stone 3x thence S 74th E 200 feet to a
stone 3x thence N 15th E 200 feet to a stone 3x thence
with Emma Street 200 feet to the beginning corner
containing one City acre more or less.

Together with all and singular the rights members
hereditaments and appurtenances to the said prem-
ises belonging or in anywise incident or apper-
taining. To have and to hold all and singular

the premises before mentioned unto the said
Jesse W. Cannon his heirs and assigns forever
and I do hereby bind myself my heirs executors
and administrators to warrant and forever defend
all and singular the said premises unto the said
Jesse W. Cannon his heirs and assigns against
me and my heirs and against every other person
whomsoever lawfully claiming or to claim the
same or any part thereof.
