David in the State aforesaid, Greenville County, in Consideration of the sum of One thousand Eighty Seven \$100 Dollars to us in hand paid at and before the sealing of these presents by J H Brantshires, in the state aforesaid, the receipt whereof is hereby acknowledged, have granted, bequeathed, sold and released, and by these presents, do agree, bargained sell and release unto the said J H Brantshires all that certain tract or portion of Land lying in Greenville County above Greenville City, containing Scars of H C Markley, W Brantshires Esq., Bachelor & Balling Scars, Beginning at H C Markley's corner N 45° W 11.50 to Right and thence N 18° E 100 ft to a Pine tree, thence N 52° W 17.50 to Rockton & Baldwin Line, thence N 31° E 16 chs to Rockton to a Pine 4.0 to H Markley's corner, thence in S 46° E 1.658 5 chs to Left Pine to our Balling line, thence South 11.60 chs to a Hickory to a Pine East 19 chs to a Rockton Pine 4.0 to H Markley's corner, thence in S 46° E 1.658 84 ft N 11.50 to the beginning corner, Together with all and singular the Rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident, appertaining, To have and to hold all and singular the said premises before mentioned unto the said J H Brantshires his heirs and assigns forever, And we do hereby bind ourselves and our heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said J H Brantshires his heirs and assigns against us and our heirs to all persons lawfully claiming, or to claim the same or any part thereof.

Common Pleas. To all to whom it may concern
Know Ye that I, J J Donahue Master aforesaid for
the County aforesaid being Master of Common Pleas and
States and Thaddeus C. States as Executors, and in their
own right, or about the 15th day of September 1884, ex-
hibited their Complaint in the Court of Common Pleas
for the County aforesaid, against William A. Blakes, A. T.
Frost & States and others demanding judgment
